Per our email exchange, here's the Exex Sum we provided last week to the SRI at its request.

Dear Rob, as I advised Hunter, we're in good shape in our preparation. We've completed our report and yesterday sent the final draft to GP and his attorneys for their comments (will send you both when finalized). We have also requested (as invited) a meeting with General Coldea at SRI to present our findings and arguments on behalf of GP.
